

# Recruitment



# Eligibility

To be considered for Mater's graduate program you must meet the following criteria:

<b>1. Qualification</b>	<ul style="list-style-type: none"><li>• Have completed a qualification in nursing and/or midwifery within 12 months of the program start date<ul style="list-style-type: none"><li>» Applicants who have completed their qualification more than 12 months prior to the start date of the graduate program are not eligible to apply</li><li>» Applicants who will not complete their qualification until after the start date are not eligible for this intake and should apply to a future intake</li></ul></li></ul>
<b>2. Work experience</b>	<ul style="list-style-type: none"><li>• Have no more than six months full time work experience as a nurse or midwife since graduation</li></ul> <p><b>OR</b></p> <ul style="list-style-type: none"><li>• Have worked no more than 900 hours since graduation if employed part time or casually</li></ul>
<b>4. Registration</b>	<ul style="list-style-type: none"><li>• Meet all requirements and eligibility to obtain AHPRA registration</li></ul> <p><b>AND</b></p> <ul style="list-style-type: none"><li>• Hold registration prior to the employment date of commencement<ul style="list-style-type: none"><li>» If you require an International English Language Testing System (IELTS) to satisfy AHPRA registration requirements these test results must be submitted with your application</li></ul></li></ul>
<b>5. Working rights</b>	<ul style="list-style-type: none"><li>• Be an Australian citizen or hold a working visa that allows full-time ongoing permanent employment in Australia<ul style="list-style-type: none"><li>» Sponsorship is not available for graduate positions.</li></ul></li></ul>

# Application tiering—registered

Mater has a responsibility to place Queensland graduates first to fill available positions. Therefore non-Queensland students will only be considered if we are unable to fill positions with Queensland applicants.

<b>Tier 1</b>	<p>Applicants who are:</p> <ul style="list-style-type: none"> <li>• undertaking their studies at a Qld university, <b>AND</b></li> <li>• Australian Citizens/Australian Permanent Residents/ New Zealand Citizens</li> </ul>
<b>Tier 2</b>	<p>Applicants who are:</p> <ul style="list-style-type: none"> <li>• are undertaking their studies at an interstate or New Zealand university, <b>AND</b></li> <li>• Australian Citizens/Australian Permanent Residents/ New Zealand Citizens</li> </ul>
<b>Tier 3</b>	Temporary visa holders and international applicants

## Commencing at Mater

Mater undertakes multiple commencement dates for graduates as part of each intake. Commencement dates will be discussed at interview with all applicants and will depend on business requirements and candidate preferences.

<b>Program</b>	<b>Commencement date</b>
New Year Graduate Program	<ul style="list-style-type: none"> <li>• February</li> <li>• April</li> </ul>
Mid Year Graduate Program	<ul style="list-style-type: none"> <li>• Late July/early August</li> <li>• Late September/early October</li> </ul>

# Application

## For your application to be considered you must submit in full:

- Resume
- Completed cover letter
- Completed preference form

## Application submission

### Submitting your application

- Applications can only be accepted by online application, emailed applications cannot be considered
- Ensure you have the entire required documentation ready at the time of submission as incomplete applications will not be considered
- Ensure you have completed and attached your cover letter
- Please ensure you read all required questions closely to ensure you are not accidentally disqualified from being considered
- Make sure your application is submitted as early as possible and do not wait until the closing date to apply
- An influx of applications on the final closing date could result in high level system demands and there is a risk of your application not being received

### After submitting your application

- Once you have submitted all of the required documentation, you will receive an automated email acknowledgment of your application (please check your spam/junk folder)
- **If you do not receive an email notification this mean we *have not* received your application, contact the Recruitment Team to confirm if your application has been received**
- Applicants will not be contacted regarding their application until after the closing date
- If you do not meet the minimum eligibility requirements (outlined on Page 5), you will receive an automated acknowledgement that your application has been disqualified
- If you are not short listed for an interview, you will be notified via email

## What you need for your interview

*If you are successful for an interview, you are required to email the information below prior to your interview.*

- Two (2) references
- ANSAT Summative Reports (or Clinical Placement Reports issued by your university)
- Any additional Clinical Placement feedback you may have received
- SPOT feedback reports (*only applicable for those who have completed placements at Mater*)
- Evidence of Australian residency status (if not an Australian citizen)
  - » **Failure to bring this documentation with you will result in you being unable to progress with your interview.**

## References

*All applicants are required to provide two references*

*References can be provided at interview or emailed from your referee prior to your interview.*

*It is your responsibility to have your nominated referees complete the reference.*


You must provide:

- One employment reference\* from your employer (current or previous if not currently employed)
- One clinical reference

Referees can be a Clinical Supervisor or a preceptor/manager/nurse or midwifery unit manager who has had director supervision of you on placement

The referee cannot be a university or Registered Training Organisation employee unless directly involved in your clinical practice in a supervisory capacity

**If you have not been employed you can provide a second clinical reference**



# Interviews

## Video screening

Video screening (or “asynchronous”) is a new form of pre-screening interview in which you, the applicant, are guided through a short online interview process through a user friendly online portal.

This video pre-selection screen can be completed at any time within the dates provided, that is suitable to you via any camera enabled device (i.e. smart phone, tablet, computer).

You will be asked questions and your answer is recorded in front of your webcam. You will have one attempt at all the questions similar to that of a face-to-face interview. In order to prepare, there will be practice questions available to you so you feel comfortable with the process before completing your screen.

## Face-to-face interviews


Interviews will be conducted by members of the recruitment and Mater clinical teams and last approximately 30-40 minutes.

Where possible you will be interviewed by a manager from one of your preference areas.

# Frequently asked questions

<p><b>Do I need to have completed clinical placements at Mater to be considered for a graduate position?</b></p>	<p>No, we do not require applicants to have completed placements at Mater.</p>
<p><b>Whom should my cover letter be addressed to?</b></p>	<p>Address your cover letter to Jo Walkley, the Graduate Nurse Recruitment Coordinator</p>
<p><b>Is Mater a part of Queensland Health's Graduate Nurse/ Midwives Online Recruitment program (GNOR)?</b></p>	<p>Mater's graduate program is not associated with Queensland Health's Graduate Nurse Online Recruitment program (GNOR), and is a private organisation founded by the Sisters of Mercy.</p>
<p><b>I graduated more than six months ago, can I still apply?</b></p>	<p>Yes, to be eligible you must have recently completed or completed within the past 12 months a qualification in nursing and/or midwifery; or are due to complete the same prior to the start date for the graduate program.</p>
<p><b>Since graduating I have worked as a nurse and/or midwife, can I still apply?</b></p>	<p>Providing you have no more than six months' (or 900 hours) work experience as a registered nurse or midwife since graduation you can still apply.</p>
<p><b>I applied for the last graduate program at Mater, can I still apply?</b></p>	<p>Yes, if you graduated within the past 12 months with a qualification in nursing and/or midwifery; and have no more than six months' (or 900 hours) work experience as a registered nurse or midwife since graduation you can apply.</p>
<p><b>What happens if I submit a late application?</b></p>	<p>Applications lodged after the closing date cannot not be accepted.</p>
<p><b>Where can I get a Mater reference form?</b></p>	<p>Reference forms will be made available to those who are invited for a face-to-face interview.</p>
<p><b>Can I provide a Qld Health reference?</b></p>	<p>No, Mater requires applicants to provide references on our own templates.</p>

<p><b>What happens if I am unable to attend an interview?</b></p>	<p>As the face-to-face interview is an essential component of the Mater interview process, if you are unable to attend an interview, we are unable to proceed with your application. If you are applying from overseas or interstate you will need to be in Brisbane at the time of the interview. The recruitment team will endeavour to contact you at the earliest possible time so that you can organise travel arrangements.</p>
<p><b>How are preferences allocated?</b></p>	<p>We endeavour to allocate candidates to their preferred programs or clinical area, but due to limited places in some areas this is not always possible.</p> <p>Your offer of employment will include the graduate program to which you have been allocated.</p>
<p><b>Can I accept an offer prior to having registration?</b></p>	<p>We are aware that you may require some time to obtain registration prior to starting on the graduate program and the recruitment process is timed to allow registration to be in place prior to the start date.</p> <p>Please note that you would not be able to commence at Mater without AHPRA Registration.</p>
<p><b>What are pre-commencement requirements?</b></p>	<p>All new starters at Mater are required to meet requirements prior to commencement. These are:</p> <ul style="list-style-type: none"> <li>• return a signed full copy of your employment contract</li> <li>• undertake and complete a criminal history and working rights check (this is paid for by Mater through CV Check)</li> <li>• meet your Mater Safety Health and Wellbeing (SHAW) requirements—return a medical history form and meet immunisation requirements.</li> </ul>
